The municipal officers are authorized under **38 MRSA 1021** to grant permits for the construction of wharves and weirs. The municipal officers are one of the three agencies/boards that must review and permit the building of the wharf. The Maine Department of Environmental Protection acts regarding the alterations of coastal wetlands and the Planning Board acts under the Shoreland Zoning Ordinance.

Under this State law, the municipal officers must ensure that the construction is not injurious to the rights of others and does not obstruct navigation.

PROCEDURE

- 1. Applicant or authorized agent must complete and sign this form.
- 2. A fee of \$200 will be paid with the application to cover the cost of advertising and administration.
- 3. Upon receipt of the completed application, the Town manager will present it to the Select Board, who will set a time and date for an on-site hearing. After the date has been set, the Town office will notify abutting property owners (by certified mail), the applicant and the members of the Planning Board of said hearing. The Town office will also set a schedule for advertising the hearing by public notice in the local newspaper for three (3) consecutive issues, the first to be at least seven (7) days before the hearing.
- 4. The municipal officers will attend the hearing with the Town clerk, who will record the proceedings. The hearing will ask for an explanation of the project by the applicant or agent, and then ask for public comment, both favorable and unfavorable. The hearing will then close.
- 5. At the next regular meeting of the Select Board, the Board will consider the application based upon the criteria set forth under **38 MRSA 1021**. After the final action, the Board will direct the Town manager to notify the Planning Board and the Department of Environmental Protection of their action and comments.
