GREETINGS:

In the name of the State of Maine, you are hereby required to notify and warn the citizens of the Town of St. George, in said County, qualified by law to vote in Town affairs, to meet at the St. George School, in said Town, on Tuesday, the 14th day of May, 2024, at 7:00PM, then and there to act on the following articles, to wit:

ARTICLE 1. To elect a moderator to preside at said meeting.

ARTICLE 2. To see if the Town will vote to charge interest on all delinquent taxes at the rate of 8.50% per annum, computed on a daily basis, and to establish two due dates for property taxes, with one-half of the tax amount due September 30, 2024, and one-half of the tax amount due March 31, 2025.

RECOMMENDED BY SELECT BOARD AND BUDGET COMMITTEE

ARTICLE 3. To see if the Town will vote to authorize the tax collector and treasurer to accept the prepayment of taxes not yet committed. Any overpayment of taxes from one year applied to the next year at the request of the taxpayer will be treated as prepayment of taxes not yet committed.

ARTICLE 22. To see if the Town will vote to exceed the property tax levy limit established for the Town of St. George by State law, due to extraordinary circumstances outside the control of the municipal legislative body. **NOTE: Must be specific and voted on by written ballot.**

ARTICLE 23. To see if the Town will vote to accept the various Federal & State Reimbursements and Grants, such as Municipal Revenue Sharing funds, Tree Growth Reimbursement, Veteran's Tax Exemption Reimbursement, Snowmobile Registration Refund, General Assistance Reimbursement, State Park Fee Sharing, State Property Tax Relief, Landfill Closure Cost Reimbursement, and Small Community Grant Program, as provided by the State Legislature to the Town in the fiscal year 2024-2025.

ARTICLE 24. To see if the Town will vote to authorize the Select Board, on behalf of the Town, to sell and dispose of real estate acquired by the Town for non-payment of taxes, or foreclosure of tax liens, and execute quit-claim deeds for the same. Except that the Municipal Officers shall use the special sale process required by 36 M.R.S. § 943-C for qualifying homestead property if they choose to sell it to anyone other than the former owner(s).

ARTICLE 25. To see if the Town will vote to authorize the Select Board, on behalf of the Town, to sell and dispose of personal property owned by the Town.

ARTICLE 26. To see if the Town will vote to authorize the Select Board to carry forward and lapse certain municipal budget balances as of June 30, 2024.

ARTICLE 27. To see if the Town will vote to approve \$122,170 from Coronavirus Local Fiscla Recovery Funds (aka American Rescue Plan Act or ARPA Funds) received by the Town from the Federal Government for the purpose of providing Emergency Medical Services.

ARTICLE 28. To see if the Town will vote to authorize the Select Board to spend funds up to 15% of the Unassigned Fund Balance as of the end of the most recent fiscal year to cover the cost of vital supplies, equipment and other items found lacking and needed for the protection of health, life and property during a proclaimed emergency.
