St. George Parks and Recreation Committee Monthly Meeting Minutes November 19, 2018

Meeting Called to Order: 6:05

Public Comment/Rec Center Concept Update discussion:

Ben visited the Wiscasset Rec Center. He sent us all notes from the visit/meeting with the Rec Director. The big take-away, the concept failed until they offered programs for Senior Citizens. They also offered community partnerships (towns that wanted to participate) /discounted rates in order to increase their revenue.

Annual operating cost: 830,000

Staff: 3 full-time, 40 part time

Revenue generated by: memberships, drop in fees, community partnerships, facility rentals, special events. Wiscasset provides 365,000 through local taxes. Yearly goal is to generate 450,000 in revenue.

They offer a variety of extra programs (i.e. yoga, karate).

Can we do something like this at a scale that would suit our community? Wiscasset has to justify their budget to the town each year. We would like to avoid that. It would be better for us to leave room to grow.

Oak Point can do some community outreach to see what the town would like to see in a Community Center.

Mike Felton brought this to the School Board. They are unsure if paying the architect is truly innovative and qualifies for funding from the School Fund that has been created. They are truly excited about the Rec Dept and the School working together. Mike is going to do a little bit more research. The earliest he can start work with Oak Point is July.

For both parties involved (School and Rec Department), our next step needs to be bringing in the 3rd party to complete the research.

Square footage on the soccer field is 48,000 square feet. Wetlands isn't an issue, if we stay within the "blue zone."

As a Rec Department, if we want to move quicker, we may have to move separately from the school. However, asking the town to approve two new buildings for similar purposes, may be difficult.

Can Boosters provide a down payment, so that Oak Point can start their Community Outreach sooner than July?

Old Business

1. Seniors Program Report: Shopping trip went well. Bus driver was a huge hit (they requested him back for next year.) Everybody got a goodie bag. 36 went. The trip season is over until June.

November luncheon went well. Herring Gut presented. December: 8th grade band.

2. Financial Report: Everything is in good shape. See attached.

3. Community Trip Update:

Downeaster tickets in April will be \$19 each again; we can round it up to \$20. In the past we have gone the Thursday of April vacation, but we can lock down the date in January. ME/BC hockey trip on 2/22: We have 50 tickets reserved. Total cost is \$1800, which means \$36/ticket. If the Boosters pays for a part of the tickets, we can reduce the price for families. It would be ideal if we can reduce the per ticket price to \$25/ticket. We would like to get this finalized so we can advertise for Christmas.

4. 2018-19 Goals:

Ben created an Action Plan document for us to keep our goals in mind.

5. Youth Basketball

5/6 boys: Josh McPhail, Brandon Caron, Cody Heal are coaching (13 boys)

5/6 girls: Summer Ward and Josh Miller are coaching(12 girls)

Practices are underway. Games start in December (Saturday games).

3⁄4 girls: 9 girls are signed up; Shasta Minery and Angie Vachon are coaching

3⁄4 boys: 21 boys are signed up; Ben and Matt Falla will coach one team; Roni Hallowell and TBD to coach the other.

Clinic for ³/₄ from 9-10:30 on December 1. Practice starts the following week. Games start December 15

K-2 clinics: January 12, 19, 26, Feb 2 from 8:30-9:30.

Because we need two teams now for $\frac{3}{4}$ boys, should we get another sponsor or just two different color shirts for Clark Island? Two different shirts.

Does the Rec Dept sponsor a 5/6 travel team? In the past, the Boosters have sponsored one tournament for each team. Brian says there is interest, but we would need a coach. Ben will get tournament info for them.

Missy motions to approve all basketball coaches; Brian seconds; all in favor.
